Supported Decision Making – Funding "Legal Supports" under your NDIS Plan?

Under Victorian laws, a person seeking decision making support may make a range of legally recognised appointment documents appointing Support Persons to assist them in various situations.

These documents give <u>legal authority</u> to the Support Persons nominated to be able to provide the desired support in situations where privacy or other laws might otherwise operate to "lock" them out.

These legal documents include the appointment of:

- a Supportive Attorney;
- a Medical Support Person; and
- a Mental Health Nominee.

These documents are particularly useful if the person with a disability gets themselves in a difficult situation and are otherwise precluded from involving another to assist them. They are also useful when the person hits a legal "road block" needing the support of another to help them to progress. Legal documents are not classically thought of as "supports" for NDIS purposes. However, we at Duncan.Legal would like to challenge that thinking! These documents operate in a way no different to a wheelchair or prosthetic limb: to protect, empower and enable.

Having this suite of documents in place for a person with a disability gives a person confidence to practice, and thus build, their decision making capacity. Making mistakes is an important part of how we all learn to make better decisions for ourselves. Knowling that there are persons appointed to provide support to help if mistakes are made, or complex decisions are required, can be a great comfort to a person with a disability, and to their family. Creation of these legal supports can be a very important part of the infrastructure put in place to safeguard them, whist encouraging growth of skills and capacity building.

Can the cost of Supported Decision Making Documents be funded as a reasonable and necessary legal "support" under a NDIS Plan?

We say "Yes" in theory, for plan managed or self managed NDIS participants only (which is about 70% of the NDIS community). However, the claiming of the cost of creating these documents is not yet a recognized support. In order to be claim the cost of preparing these legal documents, the **foundation for claiming** must be properly laid. This means that:

- 1. building capacity to make decisions must be **relevant to a stated goal** of the participant in their NDIS Plan;
- 2. funding for this legal support must be advocated for at the Planning meeting, and shown to be **reasonable and necessary**; and
- 3. such funding must actually be **approved** in the person's plan, or there must be flexibility in the plan to use more general core or capacity building funding for this purpose.

To date, Duncan.Legal is aware of a number of Self Managed participants successfully claiming the cost of this type of legal support. And we are also aware of some knock-backs from Plan Managers. However, supported decision making is now squarely in line with the NDIA's policy newly released in April 2023.

Reasonable and Necessary

Supported Decision making documentation provides safeguarding and scaffolding to persons who want to confidently build decision making capacity in relation to decisions that have legal consequences. This type of support is protective, empowering and brings confidence. SDM documents (SAA, MSP and MHN) cannot be created by anyone other than legal professionals, so recourse to a lawyer is therefore "necessary" to build this scaffolding.

The cost of preparing these documents is a one-off package of sessions that are very reasonably priced. Additionally, the appointing of support persons means that there are unpaid volunteers undertaking key support roles. This may obviate the need for paid support workers in the future, and thus lessen the overall claim on the public purse.

Be part of the Paradigm shift

Supported decision making represents a significant paradigm shift that is critical to a person with a disability achieving a good life. Whilst claiming funding for this legal support is relatively untested, we invite you to be bold in your planning meetings and discussions with your Plan Managers and Support Coordinators. Just because it hasn't been done so far or perhaps doesn't fit into existing categories doesn't mean it shouldn't be funded. Be part of the changing narrative. Have a GO!

IMPORTANT UPDATES

SDT Indexed Limits for 2023/2024FY

Each year the Income Assets Test Exemption & Annual Expenditure Limits are revised for SDT's.

01 July 2023 to 30 June 2024, the threshold for SDT assets before the pension start to reduce is: \$781,250

There is <u>no</u> limit that can be spent on care & accommodation of the principal beneficiary however there is a limit on other discretionary spending (e.g. entertainment, travel etc).

The discretionary spending limit for **01 July 2023** to **30 June 2024** has also been increased to: **\$14,000 p/a**

Increase in stamp Duty Exemption for property gifted to an SDT

The *Duties Act 2000* has been amended from 1 July 2023 to increase the property value threshold for this duty exemption from \$500,000 to \$1.5 million where the property will be used and occupied as the principal place of residence of the primary beneficiary of the SDT.

If the value exceeds \$1.5 million, the duty will be assessed on the amount that exceeds the new threshold.

New duty exemption for a transfer of land to a person with a disability

The **Duties Act 2000** has also been amended from 1 July 2023 to introduce an exemption for a transfer of property from an immediate family member to a person with a disability who would be eligible to be a primary beneficiary of an SDT even if an SDT has not been established. The exemption is available from 1 July 2023 for properties valued up to \$1.5 million.

Special Disability Trust Is it a good option for your family?



If you wish to explore whether a Special Disability Trust ("SDT") is a good option for your family member with a disability, we suggest you order our **Special Disability Trusts webinar**. Following that, you are welcome to make an appointment with Duncan.Legal to discuss your options.

Before planning an SDT, you must have your person with a disability deemed eligible as a beneficiary of an SDT by Centrelink (Services Australia).

How – Telephone Services Australia (Centrelink) on **132 717** and ask to speak with a **COMPLEX ASSESSMENT OFFICER** (this <u>cannot</u> be done in person at a Centrelink Customer Service Centre).

What – Obtain a letter from Services Australia confirming that your person is eligible as a beneficiary of a Special Disability Trust. Once you have your letter of eligibility, you can seek legal advice as to whether you should set up an SDT now or through your Will.



Safeguarding Decision Making - 2 Part online webinar Dates: Friday 8th and Friday 15th of September, 2023

Duncan.Legal is privileged to be invited to present at an upcoming Belonging Matters Safeguarding Decision Making webinar series. Together with co-presenter Michelle Browning, we will be exploring the Supported Decision Making concept and the legal supports that are available.

What is this webinar series about?

Supported decision-making is an important concept as it actively engages people with cognitive disabilities in making decisions that affect their own lives. We will explore how to support people to make important legal decisions such as when they consent to a medical procedure, sign a service contract or open a bank account. Some people with cognitive disabilities may struggle to understand these types of legal decisions without the support of family, friends and supporters.

In Victoria, there are a number of legal roles people with disability can use to ensure they get the support they need when making important legal decisions. This workshop will explore what these roles are and how they can be put in place to legally safeguard and ensure supported-decision making, rather than substituted decision-making or the exclusion of supporters who know the person well. A decision-making supporter can legally assist a person to:

- Understand complex information and make informed decisions in a way that meets their vision and goals
- Know that if they make a mistake, they have a trusted person available to support them
- Overcome privacy barriers or "roadblocks" with companies e.g. banks, phone companies, support agencies, NDIS
- Explore resolutions to problems and make progress towards their goals.
